# **HUD HMIS 2022 Data Standards Changes**

September 2021

**HUD and its partners have rolled out a couple key changes to the HMIS Data Standards, effective October 1, 2021**. These changes represent a continued effort to capture higher-quality data, make data labels more inclusive, and help HUD identify disparities in homelessness services.

We expect to incorporate these changes in HMIS as quickly as possible during the first week of October.

As part of the data standards changes, new CAPER and APR reports are being released. Any CAPER or APR that is due to be submitted to HUD on or after 10/1/2021 must be the new versions of the report. Unfortunately, WellSky will not have the new reports available to users until the **week of** 10/11/2021. If a CAPER or APR is required to be uploaded in SAGE on or after 10/1/2021 but before the new reports are available, please request a deadline extension from HUD here: <a href="https://www.hudexchange.info/program-support/my-question/">https://www.hudexchange.info/program-support/my-question/</a>

Data collection <u>guidance</u> has been revised so that clients may select as many responses to the Gender field as they would like to, with up to a total of five options possible for a client's preferred identity, need or situation. Existing entries for Trans Female and Trans Male will automatically be updated to have "Transgender" selected as well as either "Male" or "Female" selected

### Changes to CoC Specific Data Elements – New Element: Moving On

Data Collected About Head of Household

Funder/Program Component HUD: CoC - Permanent Supportive Housing

**Project Type Applicability** PH – Permanent Supportive Housing

**Collection Point** Occurrence Point (as provided)

Moving On: A program that assists tenants who are ready and wish to leave PSH by connecting them with affordable housing, financial assistance, and transition supports (services to help tenants prepare for, navigate, and adjust to their transition out of PSH).

**Question 1**: Date of Moving On Assistance

**Question 2**: Moving On Assistance

### **Other Changes**

- Logic change for "Date of Birth Quality" responses to be conditional based on date of birth. For example, you may not be able to select "Unknown", "Client Refused", "Client Didn't know" if you have typed in a full valid birth date.
- Housing Move-In date check to make sure the date is between Entry and Exit date
- Head of Household will be a required field
- In the Entry/Exit, logic may change to prevent you from selecting a "Relationship to Head of Household" of "Head of Household" if another client on the Entry/Exit is already designated as "Head of Household". Also some logic change to make sure there is 1 client marked as "Head of Household" for each Entry/Exit
- Wording change across the board from "Mental Health Problem" to "Mental Health Disorder"
- Wording change across the board from "Substance Abuse" to "Substance Use Disorder"
